The professorship is a tenured position with the legal status of a civil servant (Beamtenverhältnis) for life and is to be filled as soon as possible.

We are searching for a person with very good scientific achievements which can be demonstrated by the corresponding acquisition of third-party funding, broad expertise in teaching, and profound experience in the area. This person should have an innovative scientific profile, oriented towards the main focus areas of the faculty, University and University Hospital. Integration in collaborative and joint projects is expected. Teaching responsibilities relate to ensuring subject-specific teaching in the degree programs in Medicine and Dentistry, and optionally in the degree program Molecular Medicine.

Prerequisites for the position are in accordance with the regulations of Art. 57 Para. 1 of the Bavarian law on innovation in higher education (Bayerisches Hochschulinnovationsgesetz; BayHIG), in addition to the general conditions from public sector employment law. Those prerequistes include a completed university degree in medicine, pharmacy or natural sciences, pedagogic suitability, particular aptitude for academic work which is generally shown by a scientific doctoral degree, and further academic achievements shown via a habilitation or equivalent that may have been attained outside academic institutions or as part of the duties of a junior professor. Leadership of a junior research group represents such equivalent academic performance under Art. 98 Para. 10 Clause 5 BayHIG.

Universität Regensburg is particularly committed to reconciling family and working life (for more information, see www.uni-regensburg.de/familienservice). To fulfill the equality directive and increase the number of female professors, we explicitly encourage applications from qualified women.

In case of essentially similar suitability, applicants with severe disabilities are given preferential consideration.
