## **The Faculty of Human Sciences invites applications for a**

### **Professorship for Learning disability pedagogy including inclusive pedagogy**

as a professorship for life at grade W 3 to be appointed as soon as possible.

We are looking for personalities who are nationally and internationally recognized through relevant publications and who have their research focus on special education and inclusion research. The professorship should represent the field of learning disability education including inclusive education in teaching and research in its entire breadth.

Relevant research activities in a school context are required. Applicants should have experience in obtaining external funding and be willing to participate in research networks and research collaborations within and outside the University of Regensburg.

Teaching responsibilities include participation in the implementation of the degree programs of the Faculty of Human Sciences, especially the special education teaching program.

The professorship is responsible for the partial courses of study in learning disability education as in-depth studies and qualification studies (cf. LPO I §§ 97, 106).

Participation in teaching in the teacher training programs is required; participation in other programs of the faculty is desired. The research should have an empirical orientation, contribute to the faculty focus on "Inclusion & Diversity, Sustainability and Digitality" and make its results fruitful for teacher education. Applicants should have appropriate interpersonal and leadership skills and be willing to participate in academic self-governance.

Prerequisites for taking up the position (acc. to art. 57 para. 1 BayHIG (i.e. Bavarian Higher Education Act) are, in addition to the general conditions as laid down in public sector employment law: a completed university degree, pedagogic suitability, and particular aptitude for academic work, generally shown by a doctoral degree, as well as additional academic achievements, such as a habilitation or an equivalent research record. Scientific research experience gained outside of a university environment, or while employed as a Junior Professor, will also be taken into consideration, and may be considered equivalent to a formal academic qualification. Proof of a teaching credential should be available and school teaching experience of several years is required.

The University of Regensburg is particularly committed to reconciling family and working life (for more information, see <http://www.uni-regensburg.de/familienservice>). To fulfill the equality directive and increase the number of female professors, we explicitly encourage applications from qualified women.

In case of essentially similar suitability, applicants with severe disabilities will be preferentially selected.

The prerequisites for an appointment under civil servant law are based on the provisions of the Bavarian Public Service Code (BayBG) and the BayHIG. Note the age limit as in art. 60 para. 3 BayHIG.

Applications complete with the usual documents (CV, certificates, award documents, publication list containing the most important publications) are to be sent in digital form only (pdf, 1 file)
