



Information on the nominations

(for students)

I. General:

Nominations must be submitted in the period from

April 22, 2024 to May 6, 2024 (12.00 noon)

separately according to **collegial bodies** Senate (Senat), Faculty Council (Fakultätsrat) or Student Convention (studentischer Konvent) to the Election Office or to the election administrator (Chancellor of the University of Regensburg). The following number of student representatives are to be elected:

¹⁾ In faculties with more than 2,000 students, the number increases by one for every additional 1,000 students or part thereof.

Only nominations submitted by the deadline will be considered. In addition, reference is made to the provisions of the Statutes for the Conduct of Elections at the University of Regensburg (Wahlsatzung).

The **Student Convention** is made up of the four people who represent the students in the Senate (Senat), the members of the Student Council and another 24 students who are directly elected.

The **Student Council** consists of the persons who represent the students in the Faculty Councils; from the Faculty of Medicine and the Faculty of Computer Science and Data Science, only the two representatives who hold the first two seats in the election to the Faculty Council belong to the Student Council.

The **Student Representation** of a faculty generally consists of seven students. They are elected to the Faculty Councils of the faculties as part of the election of the students. If the number of students who are members of a faculty exceeds 2,000, the number increases by one for every additional 1,000 or part thereof. The Student Council Spokespersons (Fachschaftensprecherin bzw. -sprecher) in the Faculty Council are the two people who receive the most votes in the election.

II. Candidature:

Only those who are included in a valid nomination can be elected. Candidates may only be named on one nomination for election to a collegiate body and only once. The names of the individual candidates must be numbered consecutively on the nomination.

The nomination must include the surname, first name of the candidates and the faculty to which they belong. If necessary for identification, the date of birth must be indicated. In addition, membership of an association of members of universities in the Free State of Bavaria and/or the field of study can be specified. To better record the data, we ask you to provide your matriculation number.

The nomination should be given a brief overall designation. It should be clear from the nomination which of the signatories is entitled to represent the proposal before the election administration and to receive declarations and decisions of the election administration. If this information is missing, the person who signed first is entitled.

The number of candidates for an election proposal may not exceed three times the number, in the case of the Student Convention twice the number of persons to be elected; this maximum number increases to twice the maximum number of students who belong to the Student Representation when the student representatives are elected to the Faculty Councils.

A maximum of the following may be proposed:

The nomination must be accompanied by the written declaration of consent to candidacy of the candidates named in the nomination.

III. Support for an election proposal:

A nomination for the election of the representatives in the **Senate** or in **the Student Convention** must be signed by at least **ten persons**, a nomination for the election of the representatives to the **Faculty Council** must be signed by at least **five persons** who are entitled to vote for the respective election in the respective group.

Eligible voters may only support one nomination for election to a collegial body. The inclusion of eligible voters in an election proposal does not exclude them from supporting that nomination.

The nomination must include the surname, first name of the supporters and the faculty to which they belong. If necessary for identification, the date of birth must be indicated. In addition, membership of an association of members of universities in the Free State of Bavaria can be indicated. To better record the data, we ask you to provide your matriculation number.

Instead of the signatures on the nomination form, it is also possible to sign for each individual candidacy and each individual support on the forms "Declaration of Consent to Candidacy" or "Declaration of Consent to Support" provided for this purpose. The completed nomination form must then be submitted to the election office together with the collected, signed forms by the deadline.

IV. Announcement of nominations:

The admitted nominations will be announced on the homepage of the University of Regensburg by May 29, 2024 at the latest.
