Election announcement for the 2024 University Elections

enact:

I. The members of the collegiate bodies to be elected:

On September 30, 2024, the term of office of the representatives of the group of students in the collegiate bodies ends. New elections must therefore be held. In accordance with Art. 19 Abs. 2 Satz 1 BayHIG, the following are to be elected:

	for the Senate	for everyone Faculty Council, except the Faculty of Medicine and the Faculty of Informatics and Data Science	for the Faculty Council of the Faculty of Medicine and the Faculty of Informatics and Data Science	for the Student Convention,
Representatives of the group of students	4	2	4	24

The composition of the Student Council (Fachschaftenrat), the Student Convention (studentischer Konvent) and the Faculty Student Representation (Fachschaftsvertretung) is determined by the elections to the collegiate bodies.

The term of office of the newly elected representatives begins on October 1, 2024 and ends on September 30, 2025.

The university election will be conducted as an electronic election.

II. Electoral Register:

Only those who are registered in the electoral register are allowed to vote; the exercise of the right to vote in the election of representatives to the Faculty Council is determined by the registration in the electoral register with the relevant faculty.

The exhibition of the electoral register in the election office (administration building, Zi.Nr. 2.21) begins

May 10, 2024 to May 15, 2024 from 9:00 a.m. to 12:00 noon.

Inspection outside of these hours is possible after registration by telephone at 0941/943-2314 or -2454 or by e-mail to wahlen@ur.de.

It will be closed on Wednesday, May 15, 2024.

Eligible voters who are registered on the electoral register will be able to retrieve their voter notification via the SPUR campus portal from mid-April (My Studies -> Student Service -> Certifivates and documents -> Reports -> "Dokument für Hochschulwahl").

A written reminder may be lodged with the returning officer against non-registration or incorrect entry in the electoral register by May 16, 2024, 4:00 p.m. (first working day after the closure of the electoral register) at the latest.

The election is managed by the Chancellor of the University.

III. Nominations:

Eligible voters are invited to vote in the period from

April 22, 2024 to May 6, 2024, 12:00 noon, postal

to submit nominations to the election management or to the election office on the forms provided for this purpose, separately according to collegial bodies (Senate, Faculty Council, Student Convention). Only nominations submitted by the deadline can be considered (cut-off period). Only those who are included in a valid nomination can be elected.

Late nominations are invalid.

An election proposal must contain the surnames and first names of the applicants as well as the respective faculty to which they belong. If it is necessary for clear identification, the date of birth must also be mentioned. In addition, the affiliation to an association of members of the universities in Bavaria as well as the field of study can be specified. The proposal should be given a concise overall designation. The nomination may not contain any further information. The nomination must be accompanied by the written declaration of consent of the candidates named therein to stand as a candidate on this nomination. Candidates for election to a body may only be named on one nomination, and only once. A nomination for the election of representatives in the Senate or in the Student Convention must be signed by at least ten people, and a nomination for the election of representatives in the Faculty Council must be signed by at least five persons who are entitled to vote in the respective election in the respective group.

Instead of the signatures on the nomination form, each individual candidate and each individual supporter can also sign the forms "Declaration of Consent to Candidacy" or "Declaration of Consent to Support" provided for this purpose. The completed nomination form must then be submitted to the

election office together with the collected, signed forms of the candidates and supporters by the deadline.

The admitted nominations will be announced on the Internet on the homepage of the University of Regensburg by May 29, 2024 at the latest.

IV. Voting:

The university elections will be

from June 12, 2024, 12:00 noon until June 19, 2024, 12:00 noon

conducted as an electronic ballot.

Access to the electr. voting room (election portal) will be activated under "go.ur.de/hochschulwahlen" during the above-mentioned period. For security reasons, voting is only possible with a valid data center account within the university network. You can connect in the following ways:

on campus:

- o You are using a PC of the university with a LAN connection (e.g. CIP pool).
- o You can connect to Eduroam on the university network with your internet-enabled device.

Off-campus:

O You can connect to your internet-enabled device via VPN access to the university network.

Elections are held on separate electronic ballot papers for each collegiate body and group. Each voter has as many votes as are to be elected to the corresponding collegiate body for the group of representatives.

The Election Administrator
