Faculty of Law invites applications for a

junior professorship of Public Law, especially Administrative Law with a focus on Law of Digitalization, Media and E-Commerce Law (grade W1 with tenure-track leading to W3)

for a period of three years in the first phase with the legal status of temporary civil servant (Beamtenverhältnis auf Zeit), to be appointed as soon as possible. The tenure-track professorship is supported by the Federal/Länder program for the promotion of young scientists (tenure-track program). Universität Regensburg offers the prospect, upon positive tenure evaluation, of transferring to a permanent position as W3 grade professor with the legal status civil servant for life (Beamtenverhältnis auf Lebenszeit). Applicants shall cover the full range of Public Law and, in particular, Administrative Law both in their research activities and in teaching. A special focus on Information Society Law is welcome. This is particularly true for Media Law. Applicants should also research and teach the influences of digitalization on traditional subjects of administrative law for instance with regard to e-government and other aspects of digitalization law. The Faculty is renowned throughout Germany for its focus Area "Law of the Information Society" and manifold other teaching and research activities in this field. Applicants are expected to join teaching in the focus area and to develop additional courses dealing with the law of digitalization. Moreover, the new colleague shall contribute to further research activities at Faculty and University level. Readiness for interdisciplinary cooperation and to participate in third-party funded projects is required for that. There is a plan to establish a new Faculty of Informatics at the University as well as to further expand on current activities in this field.

In the event of a positive interim evaluation, the civil servant status is extended for a further three years and teaching authorization is granted. In the sixth year after the appointment, a final evaluation of the achievements in research and teaching takes place. In the event of a positive evaluation, the candidate will be offered a permanent W3 professorship.

Prerequisites for taking up the position are, in accordance with Art. 14 Bavarian University Staff Act (BayHSchPG), alongside the general conditions from public sector employment law, a completed university degree, pedagogic suitability, and particular aptitude for academic work, generally shown by a doctoral degree. Insofar as the candidate undertook employment as a research associate or research assistant after their doctorate, the duration of the doctoral studies and the employment should not exceed six years in total.

Applicant must have changed universities following the doctorate or have been academically active for at least two years somewhere other than Universität Regensburg before the application.

Universität Regensburg is particularly committed to reconciling family and working life (for more information, see <http://www.uni-regensburg.de/chancengleichheit>). To fulfill the equality directive and increase the number of female professors, we explicitly encourage applications from qualified women.

In case of essentially similar suitability, applicants with severe disabilities will be preferentially selected.

The prerequisites for appointment under civil servant law are based on the provisions of the Bavarian Public Service Code (BayBG) and the Bavarian University Staff Act (BayHSchPG).
