Motherhood Wage Penalty in Russia: Empirical Study on RLMS-HSE data

Abstract: The research paper is dedicated to the analysis of monthly and hourly wages of mothers and non-mothers in Russia. Russian Longitudinal Monitoring Survey HSE is used for the data basis to estimate the motherhood wage penalty between workingwomen without children and working mothers. The study discloses 11% penalty for mothers in their hourly wages on average in Russia in the period of 2000-2015. Despite same level of education, tenure, qualification women with two and more children are paid considerably less than women without children. The small age of the youngest child affects the working hours which reduce the monthly wage considerably, but it does not impact the hourly wage. The research shows that the motherhood wage penalty in Russia is lower than in Germany, UK or the US especially for the mothers with pre-school age children.

Laurent Warlouzet:

Governing Europe in a Globalizing World. Neoliberalism and Its Alternatives following the 1973 Oil Crisis

Abstract: I examine how Western Europe adapted its economic and social policies to the shock of Globalization, focus on the period ranging from 1973 to 1986 and provide a broader interpretative framework of the relationship between Europe and globalization up to now. I challenge the narrative of the inevitable emergence of a neoliberal Europe by demonstrating that alternatives were discussed and implemented. Hence, I examine the interaction between three models of economic and social policies: socially-oriented, neomercantilist and market-oriented Europe. Neoliberal policies fit into the last category as a radical variant of market-oriented policies. I also show that European leaders often chose the EEC only after having exhausted other options, either national or international (OECD, GATT, ILO), and not out of idealism (or not only for that).

Veronika Püschel:

Progressive Pensions as an Incentive for Labor Force Participation


Abstract: In this paper, we challenge the conventional idea that an increase in the progressivity of old-age pensions unanimously distorts the labor supply decision of households. So far, the literature has argued that higher pension progressivity leads to increased redistribution and insurance provision on the one hand, but increases implicit taxes and therefore distorts labor supply choices on the other. We show that a well-designed reform of the progressivity of a pension system, which introduces a progressive pension component linked to the employment decision of households, has the potential to encourage labor force participation, and could therefore lead to more instead of less employment. We evaluate the strength of this positive employment effect in a quantitative stochastic overlapping generations model with productivity and longevity risk, and show that it can be sizable.
