

Privacy policy in connection with your application at Universität Regensburg (UR) for a room in a student dorm of the Studentenwerk Niederbayern/Oberpfalz or another private student dorm in Regensburg:

Purpose of the data processing:

Your data is used for the following purposes:

- * in a pseudonymized form, creating statistics

For accommodation in a Studentenwerk dormitory, the following regulations apply:

Universität Regensburg (University of Regensburg) and the Studentenwerk Niederbayern/Oberpfalz (Student Union for Niederbayern/Oberpfalz) are jointly responsible for the processing of your personal data, according to Art. 26 DSGVO (Datenschutzgrundverordnung, General Data Protection Regulation, GDPR). Your personal details will be collected directly from you by the University of Regensburg and shared with Studentenwerk Niederbayern/Oberpfalz for the common purpose of providing you with a room in one of the student dormitories. University of Regensburg complies with the obligation to inform the person concerned during the collection of personal data, according to article 13 DSGVO.

Furthermore, the Studentenwerk Niederbayern/Oberpfalz and the University of Regensburg are responsible for the following processing of data:

Studentenwerk Niederbayern/Oberpfalz:

a. Processing of personal data in order to create rental contracts

b. Saving personal data for the duration of the rental contract and beyond, in so far as legal obligations may demand it

c. Communicating with the persons concerned in the form of information for tenants

d. Communication about processed data with the International Office of the University of Regensburg for the duration of the rental contract and until the back payment of the room deposit.

University of Regensburg

a. Collection of data from the persons concerned

b. Sharing of personal data with Studentenwerk Niederbayern/Oberpfalz in so far as is necessary for the issuing of a rental contract and the administration of the tenancy

c. Communication with Studentenwerk Niederbayern/ Oberpfalz on processed data for the duration of the rental contract and until the back payment of the room deposit.

Both Studentenwerk Niederbayern/Oberpfalz and the University of Regensburg ensure the technical and organisational measures to comply with the rights of the persons concerned within the legal time period as stipulated in Chapter 3 DSGVO (Information, disclosure, rectification and erasure, data portability, objection, as well as automated decision finding in individual cases).

Studentenwerk Niederbayern/Oberpfalz and University of Regensburg are committed to comply with the rights of the persons concerned for their respective data processing acts.

The duration of the storage of personal data

The data is stored as long as it is necessary to fulfill the purposes named above in accordance with Art. 4, paragraph 1 BayDSG

Right of revocation of consent
